# **PRESIDENT'S COLUMN**

It is another busy year for ACCP as we as an organization pursue our objectives addressing the three critical issues defined in our strategic plan—to develop,

advance, and position clinical pharmacists in practice, research, and education. In my opinion, the PRNs remain the lifeblood of the organization, serving as the vehicles that permit and encourage our members to remain connected and interactive throughout the year. The PRNs represent the single greatest member benefit for many ACCP members. I would like to share many important issues with the PRNs in this column to hopefully generate both awareness and discussion among the many members who interact regularly with their PRN colleagues, but space limits restrict me to the three topics below.

#### Medicare Coverage Initiative for Direct Patient Care Services of Qualified Clinical Pharmacists

This is the "official" title for the ACCP pharmacist— "provider initiative." The two-page document at www. accp.com/MedicareBrief should be considered required reading for all ACCP members—it will require only a few minutes of your time.... This document summarizes in clear, brief language the purpose, background, and rationale-the "what" and the "who" of this initiative. The title is very important because it emphasizes that this is about benefits provided to a patient by gualified clinical pharmacists (i.e., it is focused on improving patient care and outcomes, not on creating opportunities for pharmacists). It also embraces the reality that the Social Security Act (42 U.S.C. and relevant sections, primarily section 1861) defines the coverage of health care services, not "provider status"; nor does it offer a list of recognized providers. This is the single largest and most important legislative and advocacy agenda item for ACCP, and this initiative will need the awareness and support of every

member as we move forward on it. The staff leadership is currently engaged in active outreach and advocacy within and outside the profession to generate support, identify partners, and engage them in this initiative. At the right time, grassroots advocacy by our members will also be an important need—so stay tuned!

A related and very important commentary endorsed by the Board of Regents (BOR) has also been released this month and should be another important piece of recommended reading ... requiring another 5- to 10-minute investment of your time. The paper, titled "Qualifications of Pharmacists Who Provide Direct Patient Care: Perspectives on the Need for Residency Training and Board Certification," is available as a prepublication draft at www.accp.com/docs/positions/commentaries/ ACCP\_Brd\_Commtry\_Final\_030513.pdf. My column in the March ACCP Report (www.accp.com/report/index. aspx?iss=0313&art=7) provides some more detailed thoughts on this paper and its central importance to the Medicare coverage initiative.

Most members will agree that this is a very important initiative and realize that it will take a great deal of work, effective strategy, and probably a bit of good luck to be successful. I encourage every PRN member to seriously consider contributing to the ACCP Political Action Committee—there has never been a more important time for us to generate resources to support the legislative agenda. #### **Board Certification Update**

Through concerted action with our partner sponsoring organizations, the well-stated ACCP objective of increasing opportunities for board certification is continuing to move forward. The Board of Pharmacy Specialists has just



announced the approval of critical care pharmacy and pediatric pharmacy as specialties. See the article on page 3 for more information on the BPS announcement.

In addition, BPS has established Practice Analysis Task Forces for cardiology and infectious diseases in response to preliminary requests for specialty recognition submitted by ACCP and partner organizations. The task forces were created as part of the process for conducting role delineation studies for the proposed specialties. We stand prepared to serve as a sponsoring organization for these specialties once a call for petitions is issued pursuant to an analysis of the role delineation studies by BPS.

BPS has also announced the movement to computerbased testing, with an expansion of both testing dates and testing locations to increase access to board certification examinations.

Another important development under the heading of board certification is the publication of a white paper by BPS that defines its 5-year vision for pharmacy specialties (www.bpsweb.org/pdfs/BPS\_Whitepaper\_Jan2013. pdf). This vision is in some ways aligned with the ACCP Medicare coverage initiative and gualifications of clinical pharmacists commentary referenced earlier. In fact, the vision paper states that there will be "a future model where board certification will be the expectation for pharmacists engaged in direct patient care." The vision also commits to the continued expansion of specialty recognition that is consistent with, but not limited to, the growth of PGY2 residency training programs, and that BPS will be considering modifications to the specialty recognition structure. These statements are not inconsistent with a white paper published by ACCP in 2009 evaluating the need to consider a restructuring of the specialty framework (www.accp.com/docs/positions/whitePapers/ Pharm2902\_ACCP-Blair-Specialists.pdf). This white paper from the BPS Board represents potentially positive developments for ACCP and its members who are heavily invested in the importance of BPS board certification.

#### **Student Chapters**

The last topic I wanted to touch on is the development toward the recognition and establishment of ACCP student chapters on the campuses of our schools and colleges. Students have been the fastest-growing membership category for the past several years, and they represent the future of the College. I believe this is a clear indication that more and more student pharmacists recognize that the future of the profession will be progressively dependent on the growth of clinical pharmacy and direct patient care, and they realize that ACCP is the professional home most aligned with that recognition. Our student members have also been very vocal about the importance to them of student chapters in order to have an organized local presence. In November, the Board of Regents authorized the establishment of student chapters and requested that staff begin the process of defining the policies and processes that will be necessary to make this a reality. The ACCP staff have been very busy working on that charge and, later this year, will announce the process and requirements for establishing student chapters. The PRNs have always been strong advocates for, and staunch supporters of, our student members and have served as a great introductory pathway for students to realize the value of ACCP membership and to serve the organization. I am certain the PRNs are going to fully embrace the increased presence and roles of our students in the organization, and with time, there may be some interesting ways for the PRNs to interact with student chapters. The creation and growth of student chapters will represent another important milestone in the sustained growth and success of ACCP as an organization dedicated to the development, advancement, and positioning of clinical pharmacists.



# PRNS PREPARE FOR ELECTIONS

The PRN election cycle is upon us. It is time for the PRNs to begin the process of determining who will serve as officers in the coming year. If you are interested in being a PRN officer or in nominating someone, please contact your PRN's chair.

#### **Election Process**

The Nominations Committee will consist of at least two individuals appointed by the PRN's chair. These individuals may be the PRN's current elected officers. Those who are on a PRN's nominations committee will be ineligible to run for office in that PRN's election that year.

The Nominations Committee should prepare a slate of candidates and shall provide information to each candidate related to the election procedures. The Nominations Committee shall also provide a time line and a list of expected duties. When possible, two or three candidates for each office shall be up for election. If only one candidate can be identified, an election will still be held, with voters given the option of identifying a write-in candidates, the PRN's Nominations Committee will be responsible for narrowing the slate to three candidates. The Nominations Committee will obtain a brief (250 words) biographical sketch or candidate statement from each the candidate.

#### Voting

As in previous years, PRN elections will be held online. PRN members will receive an e-mail from ACCP that outlines the voting procedure. Members will use their log-in and password to access the ACCP Web site. Each member will then be able to access the ballot for each PRN of which he or she is a current member. Members should review their e-mail and the ACCP Web site for further news about online voting as the election draws closer.

# BPS APPROVES PETITIONS RECOGNIZING PEDIATRICS AND CRITICAL CARE AS NEW SPECIALTIES

The Board of Pharmacy Specialties (BPS) Board of Directors has approved petitions to recognize the areas of pediatric pharmacy practice and critical care pharmacy practice as specialties in pharmacy. The BPS announcement is available at <u>http://www.bpsweb.org/news/pr\_041513.cfm</u>. ACCP, working collaboratively with the American Pharmacists Association (APhA), the American Society of Health-System Pharmacists (ASHP), and the Pediatric Pharmacy Advocacy Group (PPAG), developed the petition to recognize pediatric pharmacy practice. For the critical care petition, ACCP partnered with APhA and ASHP. In both cases, the petitions were developed by a working group consisting of a practitioner-clinician member in the specialized area of practice and a member of the professional staff from each organization. Both petitions were submitted to BPS in November 2012.

BPS will now begin the process of forming a specialty council for each new specialty, which will be charged with developing the certification examination, proposing eligibility criteria for pharmacists to take the examination, and managing other required details for BPS to consider in implementing the certification processes. Examinations in both specialties will be available as early as 2015. Further information about the time line and process can be found during the next few weeks on the BPS Web site (www.bpsweb.org).

# TEST YOURSELF ON ACCP'S RECERTIFICATION PROGRAMS AND THEN CHECK THE DASHBOARD

As an ACCP member, you're the first to hear about new programs available from ACCP for specialty recertification. But how much do you really know about new and improved products for recertification in pharmacotherapy and ambulatory care pharmacy? Take the following quiz to find out, and then read on for news about the ACCP Recertification Dashboard: a new recertification planner to help you stay on track as you work toward recertification.

#### **Test Yourself**

1. True or false: A Board Certified Pharmacotherapy Specialist can no longer recertify using PSAP alone.

**Answer: False.** The new six-book PSAP series offers 40 hours per year of continuing pharmacy education credit approved by BPS for BCPS recertification. That's 120 available hours from 2013 through 2015, plus another 120 hours from 2016 through 2018. All together, PSAP will offer 280 hours of recertification credit over a 7-year recertification cycle.

In addition, you will now have 4 months to complete and submit each PSAP module—a full month longer than in previous editions.

#### 2. True or false: Board Certified Ambulatory Care Pharmacists can use PSAP to recertify in ambulatory care pharmacy.

**Answer: False.** ACCP has just introduced a new home study series developed specifically for recertification in ambulatory care pharmacy: the *Ambulatory Care Self-Assessment Program* (ACSAP). The six scheduled releases in the ACSAP series are electronic books (PDFs) with enhanced interactivity. Intra-document links lead you from the table of contents to specific chapter topics; authority links take you to current guidelines, online tools, or agency resources; and hundreds of reference links connect you to PubMed, the Cochrane Database, and other compilers so that you can access the original sources of this information.

ACSAP is available in an e-media package that allows access on phones, tablets, and e-readers. ACSAP will offer a minimum of 20 hours of BCACP recertification credit annually through the release of two electronic books—the first in January, followed by a second in July. # 3. True or false: The pharmacotherapy prep course can be used for recertification.

**Answer: True.** Board Certified Pharmacotherapy Specialists may use the Pharmacotherapy Preparatory Review and Recertification Course up to two times during a 7-year recertification cycle, in nonconsecutive years. The course is available live and in a variety of home study formats. It will provide a minimum of 21 hours of BPS-approved recertification credit annually. This means that a pharmacotherapy specialist could earn at least 42 hours of recertification credit by participating in the review and recertification course twice during his or her 7-year recertification cycle—if the courses are taken in nonconsecutive years.

4. True or false: All the recertification offerings for ambulatory care are released in the spring and summer. If you miss them, you'll have to wait until next year.

**Answer: False.** BCACPs can attend the live presentation of From Theory to Practice: Clinical Reasoning Series in Ambulatory Care Pharmacy, offered as a presymposium at ACCP's Annual Meeting each October. With new content each year, the live program allows BCACPs to earn a minimum of 6 hours of BPS-approved recertification credit in ambulatory care pharmacy every year.

5. True or false: PSAP won't work on portable electronic devices.

**Answer: False.** When you purchase the PSAP E-Media Package, you'll receive the basic version of the product: online printable PDFs that include full text, full-color graphics, and self-assessment questions; hyperlinks to outside resources such as official guidelines; reference links to compilers such as PubMed; and multimedia elements (audio and video). You'll also receive the full text (without graphics) and self-assessment questions for e-reader devices—phones and tablets. In addition, you will receive both the graphics as separate image files and the PSAP audio companion.

Here's a final bonus question to test your knowledge of BPS recertification requirements generally.

True or false: To make sure you've earned enough credits to recertify using continuing pharmacy education, it's best to complete as many hours as possible early in your recertification cycle.

**Answer: False.** In the early years of the recertification cycle, BPS limits the number of hours that can be counted toward recertification, although all the required hours may be earned later in the cycle. For pharmacotherapy specialists, that means that no more than 60 hours may be earned before the end of the fourth year of the cycle. For specialists in ambulatory care pharmacy, no more than 50 hours may be earned before the end of the third year of the cycle.

# NEW ACCP RECERTIFICATION DASHBOARD TO HELP RECERTIFICANTS STAY ON TRACK

If you're feeling a bit overwhelmed with information about available offerings for recertification, and keeping track of your hours earned, help is on the way: the ACCP Recertification Dashboard. ACCP has just released the new online recertification planner to help members who are board certified in oncology, pharmacotherapy, or ambulatory care—the specialties in which ACCP is the provider or co-provider of recertification offerings. The free online planner is designed to help you keep track of hours earned and upcoming offerings available to you, all within the requirements set up by BPS, so that you're better organized and better prepared for each recertification cycle.

# GUIDANCE ON PRN E-MAIL LIST DISCUSSIONS

The PRN e-mail lists are intended to facilitate and stimulate meaningful and appropriate discussion among PRN members concerning professional issues in patient care and appropriate drug therapy. Discussions concerning challenging clinical questions or therapeutic approaches are not only appropriate but are also welcomed. Clearly, these are benefits to each PRN member and are encouraged.

However, it is imperative that the PRN e-mail service not be used in a way that might be perceived by an outside agency as contributing to any illegal or unethical conversations. For example, discussions, questions, or answers concerning the establishment of specific prices, charges, costs, or values for products or services could be perceived as price collusion between competing clinicians or institutions. Recommendations favoring or disfavoring a particular vendor, service provider, or product could be viewed as an illegal boycott. Even if the answers sought appear to be couched in a seemingly harmless survey, it should be understood that these types of inquiries could result in time-consuming, expensive, and detrimental investigations by an outside agency/authority. For these reasons, ACCP strongly encourages all PRN members to avoid these types of questions or surveys so that the integrity of ACCP and the PRNs does not come into question.

Following are suggestions for the effective use of the PRN e-mail lists to facilitate communication among PRN members.

#### **E-mail List Etiquette and Procedures**

- 1. Include a signature on all messages. The signature should include your name, affiliation, location, and e-mail address.
- 2. Clearly articulate in your communication whether the information being provided represents factual information/data or is a professional or personal opinion.
- 3. Recognize, and be sensitive to the fact, that use of the e-mail list is a "public" activity subject to the subpoena power of law enforcement authorities, like most other forms of communication. There should be no expectation of privacy in e-mail list communications.
- 4. It is recommended that you send all of your messages to an e-mail list in plain text format as opposed to rich text or HTML.
- 5. When you receive a message directed to the list, selecting the Reply button in your e-mail program

will send the response to the author of the message. Selecting the Reply All button in your e-mail program will send your response to the original author as well as the entire list. Always double-check the name or address you are replying to when responding to a message transmitted by an e-mail list.

- 6. If you receive an unwanted message from a list member who does not observe these rules, please do not respond to the list. Instead, ignore the message or, if you feel the need to respond to the sender, make certain you reply only to the sender.
- 7. If you plan to use an automatic e-mail response to indicate that you are out of the office, please remember to set your subscription type to NOMAIL until you return.

#### **Prohibited Communications**

The following types of communications must be strictly avoided on all PRN e-mail lists because of their actual or perceived violation of federal laws related to restraint of trade and/or anti-competitive practices:

- 1. Comments, recommendations, questions, or answers concerning the establishment or amounts of specific prices, charges, or costs for products and/or services, sharing of fee structures, or financial information that could suggest possible price collusion between competitors (e.g., competing clinicians or institutions).
- 2. Recommendations that favor or disfavor a particular vendor or service provider based on the price of those services (e.g., directly or indirectly recommending a "boycott" of a product or service based on price).
- 3. Opinions that stray toward or may suggest prohibited activities cited above.

#### **BPS Approves Critical Care Pharmacy as New Specialty**

BPS has announced the approval of critical care pharmacy as a new specialty. The approval of pediatric pharmacy as a specialty was announced at the same time (see related article on page 3). As most of you know, BPS conducted a role delineation study of critical care pharmacy practice and subsequently issued a request for petition last year. ACCP, ASHP, and APhA collaborated on developing the petition that was submitted to BPS in November 2012. # Medicare benefit initiative to recognize clinical pharmacists' direct patient care services ("provider status")

Last December, ACCP announced the launch of a formal initiative to pursue recognition of direct patient care (DPC) services by clinical pharmacists as a covered benefit under the Medicare program (www.accp.com/ report/?iss=1212&art=1). The framework of this initiative should resonate well with critical care pharmacists because it is focused on DPC (assessment of patients and their pharmacotherapy needs; initiation, modification, or discontinuation of patient-specific drug therapy; and ongoing monitoring and follow-up) as members of a team providing interdisciplinary patient care. This is the essence of the model of the clinical pharmacist's role as a member of the critical care patient care team, which the specialty has embraced for more than 2 decades. As our health care delivery system evolves under health care reform, it is more important than ever that clinical pharmacy and the value we bring to patient care are recognized by CMS (Centers for Medicare & Medicaid Services) and other payers. Because fee-for-service reimbursement, as we know it, is going away, it is difficult to know what might evolve as the financial impact of "provider status," but it is important that clinical pharmacy have a "seat at the table" in a reformed system of health care delivery. It is also imperative that we articulate that this initiative is not about pharmacy or pharmacists, but about patients. We believe the active engagement of clinical pharmacists on the patient care team improves quality and outcomes by "getting the medications right."

consulting firm with a track record in lobbying, for provider recognition. The Federal Group will provide strategic government relations and advocacy services to assist ACCP in pursuing this goal. It will be a potentially long and challenging path to travel, but ACCP has defined this as our most important policy and advocacy agenda item. Please take a few minutes and read the related articles in the December and January *ACCP Reports*, which include an FAQ document to help clearly define the goals and principles underlying this effort.

#### **Student Chapter Recognition**

For those of you in academia (or students), the Board of Regents made an important announcement after the October board meeting. ACCP has decided to create a mechanism for the formal recognition of student chapters. Students make up the fastest-growing membership category in ACCP, and the student members have made it clear to the board that recognition of student chapters on school campuses is very important to them. At the request of the Board of Regents, ACCP staff are currently working on the details of chapter recognition, which should be made public sometime later this year, together with the time line for implementation. This creates an exciting opportunity to spread the word about the benefits of ACCP membership to more students and to offer options for local engagement in a chapter of a national pharmacy organization that is focused on developing, advancing, and positioning clinical pharmacists. The number of student chapters is expected to increase steadily in the next few years, which will further promote the growth of our student membership. This is not only great for the current vitality of the organization, but is also an investment in the future of the organization and the discipline of clinical pharmacy.

Each team advancing to the quarterfinal round held at the ACCP Annual Meeting will receive three complimentary student full meeting registrations. Each team member will receive an ACCP gift certificate for \$125 and a certificate of recognition. In addition, semifinal teams not advancing to the final round will receive a semifinal team plaque for display at their institutions. The second-place team will receive a \$750 cash award (\$250 to each member) and a commemorative team plaque. # **WASHINGTON UPDATE**

ACCP Medicare Coverage Initiative – Direct Patient Care Services of Qualified Clinical Pharmacists as a Covered Medicare Benefit

ACCP considers the PRNs one of its major strengths as an organization. ACCP's PRN members collectively possess a depth of clinical knowledge and expertise that substantially contribute to the College's success.

Just as the PRNs are a vital resource for our strategic mission to develop, advance, and position clinical pharmacists, so too are PRN members essential to our advocacy efforts around the pursuit of achieving recognition of pharmacists' direct patient care services as a covered Medicare benefit.

Our advocacy message focuses on the belief that, to ensure patient-centered, interprofessional health care teams "get the medications right," qualified clinical pharmacists must be fully integrated into care delivery.

As we define a consistent standard of practice that we believe can help the Medicare program deliver on its "Triple Aim" of better care for patients, better outcomes for populations, and lower costs for the program, there are no better advocates for this effort than the clinical leaders who deliver these services to patients across the country.

#### **Outlook for the 113th Congress**

The challenging political environment in which we are working to advance our initiative underscores the necessity of PRN members becoming actively engaged as advocates on behalf of the profession.

The need to address our nation's budget deficit dominates the political landscape in Washington. The legislative branch, which once reveled in bloated spending measures weighed down with earmarks and "pork," is under immense pressure to slash spending. Of note, the formerly dominant <u>House</u> and <u>Senate</u> Appropriations Committees, whose chairmen consolidated their own political power through control over annual spending bills, have seen their stature decline as Congress has scaled back its expenditures.<sup>1</sup>

The \$85 billion in spending cuts under the terms of the sequestration triggered by the failure of Congress to reach a comprehensive debt-reduction deal by a self-imposed March 1 deadline points to the ongoing stalemate in Washington. Sequestration, after all, was never intended as a solution to government spending but rather was conceived in the hope that the threat of sweeping, across-the-board cuts would encourage both sides to reach a compromise.

Dramatic differences between the <u>House</u> and <u>Senate</u> fiscal 2014 budget resolutions further indicate that political Washington remains as gridlocked as the traffic on its notorious Beltway.

However, leaders from both parties have expressed cautious optimism that a solution may be reached.

Early in March, House Speaker John Boehner (R-OH) proposed a deal that would avert a government shutdown when the continuing resolution currently funding government operations expires on March 27.<sup>2</sup>

Responding to criticism about the president's failure to work effectively with Congress, the White House launched its own "charm offensive," including several meetings with key congressional Republicans, which initially yielded favorable feedback. Of importance, the Obama administration has increasingly referred to entitlement reform, in addition to revenue increases, as part of its overall platform for deficit reduction.<sup>3</sup>

Discussion on the Hill (including a series of important <u>committee hearings</u>) regarding entitlement reform and the need to address the system of Medicare payment, rather than simply propose cuts to the program itself, suggests that Medicare reform legislation will advance with this Congress.

ACCP believes that our Medicare initiative focusing on "getting the medications right" for Medicare beneficiaries is closely aligned with the quality-based, patient-centered, multiprofessional approach to care that policy-makers already acknowledge as necessary to preserve the long-term integrity of the Medicare program.

Despite the challenging political environment, we are optimistic that with the full engagement of our members, our effort will ultimately be successful.

#### Advancing Our Medicare Initiative Through Grassroots Action

We believe that our investment in our Washington office and advocacy activities for the past 12 years leaves us well placed to move our initiative forward. But our success ultimately lies in the engagement of ACCP members to help their elected officials understand the importance of getting the medications right as part of patient-centered, team-based models of care delivery.

With more than 13,000 members, not to mention their professional colleagues and patients, ACCP has the potential to exert considerable influence on Capitol Hill. But to realize this potential, we need the active participation of all our members as grassroots advocates.

#### **Identifying Political Champions**

In seeking potential champions to advance our initiative in Congress, we need to identify elected officials who not only share our vision of a more patient-centered, team-based, and quality-focused approach to Medicare but also sit on the congressional committees of jurisdiction over the Medicare program itself.

In the House of Representatives, jurisdiction over Medicare is shared between the Energy and Commerce Committee and the Committee on Ways and Means. In the Senate, the Finance Committee oversees Medicare issues. Members who sit on these committees are best placed to introduce legislation on behalf of ACCP and work to ensure its passage into law.

In addition, legislation would ideally be introduced in a bipartisan manner, meaning a Republican and a Democrat from a committee of jurisdiction would work together to cosponsor a bill on our behalf. Although we acknowledge the challenge of identifying bipartisan cosponsors from the key committees of jurisdiction, we have taken care to ensure our legislative proposal is entirely nonpartisan and focused on issues that members from both parties can agree on—improving quality and lowering costs in the Medicare program.

To determine whether your elected officials sit on a committee of jurisdiction, visit our <u>Legislative Action</u> <u>Center</u> and enter your zip code to view your congressional delegation. Check your work zip codes as well as your home address—especially if you practice at several sites. Members of Congress will be interested to learn about innovative, cost-saving care delivery going on in their district, even if you are not a constituent residing in that district.

#### ACCP's Step-by-Step Guide to Hosting a Visit of Elected Officials to Your Practice

A key element in the internal ACCP discussion leading up to the launch of our legislative initiative was around the need to develop a consistent, standardized process of patient care—recognition that clinical pharmacists' contributions to patient care are often difficult to define and could act as a barrier to achieving recognition and payment for those services.

If this definitional question persists even within the health care community, it is understandable that lawmakers in Congress might struggle to grasp what we are proposing when we call for Medicare Part B coverage of comprehensive medication management services delivered by qualified clinical pharmacists.

Hosting a visit of your elected officials to your practice is perhaps the single most important thing you can do to help lawmakers understand what team-based, patient-centered clinical practice is all about—and to generate their support for recognition and payment for clinical pharmacists' services.

A visit also serves as a means to establish an ongoing constructive dialogue with your congressman or senator, and his or her staff, on issues important to the delivery of team-based, patient-centered care.

# Advancing Our Medicare Initiative Through the ACCP Political Action Committee (ACCP-PAC)

There is a widely used analogy of advocacy as a three-legged stool—with the three legs consisting of

direct lobbying, grassroots action, and financial support for candidates.

Political contributions are an essential component of our grassroots advocacy toolkit, helping to raise our profile on Capitol Hill and show our support for members of Congress who share our vision for clinical pharmacists in an evolving Medicare program.

A well-funded PAC can be used to show the support within the profession for our legislative initiative and the importance that ACCP members attach to moving it forward in Congress.

#### ACCP PBRN Announces First Research Publication

The American College of Clinical Pharmacy Practice-Based Research

Network (ACCP PBRN) is pleased to announce the publication of its first research paper in the March 2013 issue of *Pharmacotherapy*. The study, titled "Drug Errors and Related Interventions Reported by United States Clinical Pharmacists: The American College of Clinical Pharmacy Practice-Based Research Network Medication Error Detection, Amelioration, and Prevention (MEDAP) Study," was written by Drs. Grace Kuo (University of California, San Diego), Daniel Touchette (University of Illinois at Chicago), and Jacqueline Marinac (formerly, Director of the ACCP Research Institute) and was supported by the ACCP Frontiers Fund.

The study's objective was to describe and evaluate drug errors and the corresponding clinical pharmacist interventions. The study involved 62 inpatient and outpatient clinical pharmacists who reported 779 medication errors during a 2-week period, amounting to more than one medication error identified per pharmacist per day. Anti-infective, hematologic, and cardiovascular drugs were most frequently associated with drug errors.

Prescribing errors were the most common type, resulting in 53% of all medication errors identified. Most (89%) pharmacist recommendations in managing medication errors were accepted by prescribers. Although most of the drug errors did not result in harm, early detection of the error by a clinical pharmacist may have prevented unnecessary morbidity.

This study highlights the potential for clinical pharmacists and the PBRN to identify opportunities

for documenting and improving the impact of clinical pharmacists on patient care. The full study report is available at <u>www.accp.com/docs/positions/research/</u> <u>MEDAP\_Drug\_Errors.pdf</u>. Two follow-up reports, one describing the feasibility of conducting research within the PBRN and the other evaluating the economic impact of the medication errors, are nearing completion.

# Update on the ACCP Activities Characterizing Clinical Pharmacists (ACCP<sup>2</sup>) Study

The ACCP<sup>2</sup> Study is a mixed methods study with the goal of developing an infrastructure within the ACCP Practice-Based Research Network (PBRN) to conduct research evaluating the impact of clinical pharmacist activities. This study's objective is to describe clinical pharmacist cognitive processes, including gathering information, setting the goals of therapy, developing a treatment plan, and communicating with patients and practitioners in the delivery of patient care in general inpatient and outpatient settings.

The first part of this mixed methods study used qualitative methods to better identify specific activities performed by clinical pharmacists in their practices. In total, 22 clinical pharmacists were interviewed by telephone. Telephone interviews were used to develop the initial focus group facilitator's guide. Six focus groups were conducted from October 2012 through February 2013. Transcripts collected from the telephone interviews and focus groups were used to identify common themes in patient care by clinical pharmacists. The results of the qualitative study are currently being analyzed and prepared for submission to a major health care conference and for publication.

The interviews and focus group transcripts are also being used to develop a point-of-care documentation tool to be used in a subsequent quantitative research study to capture the activities of a single clinical pharmacist interaction with a patient. From this study, the PBRN will be better able to describe and understand factors that influence patient care delivery by a clinical pharmacist. The quantitative study will be conducted using the PBRN and will begin recruitment after IRB approval is obtained. Inpatient and outpatient clinical pharmacist PBRN members will be contacted by e-mail in the near future to request their participation.
