### ***A Note From President Barry Carter . . .*** **Task Force on PRNs to Advise Board of Regents**

ACCP's Practice and Research Networks have now been around for about 10 years. As originally envisioned, the PRNs were intended to be informal, grassroots networks of members who share a common area of practice or research.

I think it's safe to say that the PRNs have been an unqualified ACCP success! ACCP's members have established 17 different PRNs. Forty-six percent of all ACCP members belong to at least one PRN, and the average PRN member belongs to 1.5 PRNs. Anyone who was at the recent Annual Meeting in Los Angeles could observe the magnitude of the role of the PRNs within the organization as they led many of the key aspects of the meeting.

From the original informal groups, ACCP's PRNs have evolved to serve their members in more defined ways, including the development of highly focused educational programming at the Annual Meeting and Spring Forum. Through their business meetings, Networking Forums, and listservs, the PRNs provide important networking opportunities. Many PRNs have addressed various other needs of their constituencies through development of PRN Opinion Papers, development of mini-sabbatical programs, offering travel awards, writing a BPS added qualifications petition, and many other activities. Another important role of the PRNs has been to provide an avenue for development of leaders within ACCP.

As ACCP continues to grow and mature, it is expected that so too will the PRNs. Such growth expands ACCP's opportunities to provide unique services that meet the professional needs of its members. As ACCP becomes larger, the PRNs provide ever increasing avenues in a smaller

group setting for members to meet and interact with colleagues who have similar interests. In fact, many members find the PRNs to be "the thing" they value most in ACCP.

Given the important functions the PRNs serve, it is imperative for ACCP to plan for continued growth as much as possible. Thus, a Task Force on PRNs has been appointed to give thought to what the future roles and responsibilities of PRNs should be within ACCP. The Board of Regents will use this paper to provide guidance and to identify issues for further exploration with the PRN or ACCP membership.

The Task Force has been asked to address the following issues:

- what roles and responsibilities are the PRNs ideally suited to fulfill within ACCP?
- how can PRNs with significant overlap in interests and activities be logically developed and maintained?
- should there be a limit put on the number of PRNs that can exist at any one time?
- what is the optimal way for the PRNs and the Board of Regents to interface?
- what, if any, role should the PRNs have in the College's policy development process?
- what other issues, if any, should be addressed by this Task Force?

Leading this Task Force is Michael Klepser, past chair of the Infectious Diseases PRN. Other Task Force members are Marcia Buck (past Pediatrics chair), Deborah Carson (past Women's Health chair), Elizabeth Farrington (past Pediatrics chair), Robert MacLaren (member of the Critical Care and GI/Liver/Nutrition PRNs), Patricia Marken (past CNS chair), Judith Smith (Secretary/Treasurer Pharmacokinetics/Pharmacodynamics PRN), and Betty Dong, Board Liaison (member, Ambulatory Care PRN).

## **PRN Elections Are Coming . . .**

If you are looking for a way to become involved, now is the time to speak up! All PRNs are seeking candidates for their upcoming PRN elections. PRN Nominations Committees are being formed, and the call for nominations will be going out in March.

If you think you might be interested in serving as a PRN officer, or would like to nominate someone for a PRN office, contact your chair at your earliest convenience. Please see the list of PRN chairs on page 4 of this newsletter for information on how to contact your PRN's chair.

Each year, there are many questions about the process followed for PRN elections. The bullets in the next column highlight several important steps in the process.

- Each Nominations Committee should consist of at least two individuals who are appointed by the PRN's chair; these individuals may be the PRN's current elected officers. Those who comprise the PRN's Nominations Committee are ineligible to run for office in that PRN's election that year.
- Whenever possible, there should be two or three candidates for each office up for election. In those infrequent cases when only one candidate can be identified, an election will still be held, with voters given the option of identifying a write-in candidate. In those cases when there are more than three possible candidates, it is the duty of the PRN's Nominations Committee to make the final selection of candidates for the slate.
- The Nominations Committee should obtain a brief biographical sketch or statement from each candidate that can be included in the ballot mailed to members. The call for nominations should be made in March of each year, and all ballots mailed to PRN members by July 15.

## **They Just Keep Growing . . .**

During the past year, each one of ACCP's PRNs has experienced continued growth. Total PRN membership increased a whopping 31%, with the number of ACCP members who belong to at least one PRN increasing by 26%.

Phenomenal! The largest growth spurts occurred for the three newest PRNs: Adult Medicine, GI/Liver/Nutrition, and Pain Management. Other PRNs with large gains include: Geriatrics 42%, Pharmaceutical Industry 36%, Infectious Diseases 33%, Immunology/Transplantation 31%, and Pharmacokinetics/Pharmacodynamics 28%.
